Lead them to make wise choices and mercifully correct them when they don't.


May they feel your presence daily in their school and seek to reflect your love to all around them.



### The Journey Continues ...

One of my seminary professors, Dr. Diane Lobody, was famous for asking the question, "Where do you see God in this?" She always asked me that question whenever I came to her grumbling about something. I could be complaining about a paper I was writing, or a book I needed to read for class, or an issue I was having at church. Whatever my complaint, Dr. Lobody would lean in with a reassuring and gentle smile and ask, "Dave, where do you see God in this?" And she wouldn't let me go until I could name where I saw God in whatever was frustrating me that day. And no matter what, I could always find the presence of God, even when a situation seemed utterly hopeless.

At our last Consistory meeting, I was approaching what I thought was one of those hopeless situations: I was going to ask the church to spend some money on something. For quite a few months now, the finances at St. Mark's have created a lot of "What are we going to do about this?" conversations at Consistory. Back in 2020 and 2021 – during the worst days of the pandemic – St. Mark's was carrying a budget surplus. I was relieved for that surplus because there were plenty of other issues we needed to navigate at that time. By the time 2022 rolled around, as we became accustomed to "the new normal" of living with Covid, the surplus at St. Mark's dwindled and became a deficit. It wasn't a huge deficit, but seeing those negative numbers on the Treasurer's report definitely caught our attention. Unfortunately, those deficits have continued into this year.

So when I came to the Consistory with a financial request, even though the request was very small and it was for a worthy cause, I fully expected the request to be denied. You see, my wife MJ volunteers at Domestic Violence Intervention in Lebanon County (also known as DVI), and she serves on their Board of Directors. DVI is a non-profit organization that provides support, sanctuary, and assistance to victims of violence in Lebanon County. The value of the services DVI provides is immeasurable. But in order to do the work they do, they need funding. One of the more creative (and successful) fundraising efforts for DVI is their annual duck race. Businesses and individuals are asked to sponsor little toy ducks that get dumped into the Quittapahilla Creek and they "race" downstream. The first duck across the finish line wins a prize for the sponsor, while the proceeds go to the services DVI provides the victims of violence in our county.

So at the last Consistory meeting, I made a request of funds from the church to be a sponsor for the duck race. All I was hoping for was the lowest level of sponsorship (which was \$35). But due to the recent deficit we've been carrying, I expected the request to be denied. Fortunately, I was only partially correct in my assumptions. While the Consistory didn't approve the church spending any money, the Consistory members in attendance (and those who were unable to be in attendance) reached into their own pockets and donated money to the cause.

Keeping in mind that I was hoping for \$35 to achieve the lowest level of sponsorship for the fundraiser, the members of the Consistory donated \$210!! That was an amazing blessing for DVI and an example of the incredible generosity of the

people of St. Mark's. And this wasn't the first time the amazing generosity of the contributors at St. Mark's has been on display. A few years ago, a financial request was made so that we could replace the old light bulbs in the sanctuary with the new highly efficient LED light bulbs. We only needed \$2,700, but in a matter of a couple of weeks, we had collected about \$4,000! So not only were we able to upgrade the light bulbs in the sanctuary, we were also able to upgrade most of the light bulbs in the office as well.

But there was another aspect to this story about replacing the light bulbs in the sanctuary that caused me to do some head scratching. January of that same year, we had to cancel two of our worship services due to bad winter weather. So, we missed two Sunday's worth of offerings. Missing two weeks of offerings put us \$4,000 behind on our budget early that year, and that \$4,000 deficit was carried into the summer months when we made the request for funds to replace the light bulbs. The \$4,000 we needed to cover the deficit was available, but folks held onto their money until we made the request to replace the light bulbs.

I tend to be a little cynical when it comes to finances in church, so I suspected the surplus we carried in 2020 and 2021 wouldn't last long. I've seen over the years at every church I've served, one of the worst things that can happen – in terms of people giving to the church – is to have a surplus of funds. When people see the church has a surplus, they tend to keep their money in their pockets. But giving to church isn't something we can (or should) turn off because the church has a surplus of funds. Our gifts to the church represent part of our commitment to the relationship we have with God. If we have a surplus each month, then that is a good problem to have and we can discuss what ministries we would like to support with those extra funds.

One of the worst frames of mind people seem to have in the church is that when we give, we are giving to the budget. Yes, we will pay for the items we see in our annual budget like salaries, utilities, maintenance, and insurance. But the money we give to the church is as much of an act of worship as singing hymns or reading scripture. And if we give more than what the budget asks, then the blessings God has given us can be a blessing for others.

So back to Dr. Lobody's question from seminary... "Where do I see God in this?" I see God in the generosity and faithfulness of the people at St. Mark's. I see God in the ministries we are performing and the lives we are touching. I see God in the opportunity we have to extend and expand the ministries we already provide. I see God in the smiling faces of the people who come through our doors on Sunday. In other words, I see God everywhere I go. I hope you do, too. And I pray you are willing to continue stepping out in faith to find God in places we never expected...even in a toy duck floating down the Quittie.

## **Mission Corner**

Thank you to all that helped in any way for the August 5<sup>th</sup> Community Picnic. We were nervous as in the first half hour, we served around 100 people. In the next hour, it was more like 20 people. Most of the people that we served walked to the picnic which says many of those are our neighbors that need assistance. We had food for about 200 people and we ended up providing meals that day for over 200 people. We just didn't serve them all at St Mark's. With the food that we took to the Lebanon Rescue Mission and the American House (both of which were very, very appreciative of the donations), our numbers were easily over 200 people served.

This would not happen without the GREAT support we have from the congregation. Whether it is shopping for the items we ask for in donation, to tracking down EZ Ups, to moving 14 tables, 88 chairs, a refrigerator, grills and garbage cans to the parking lot, to getting the appropriate permits, to serving right along with us in those lines, to praying for beautiful weather, we say **THANK YOU** for helping us help our neighbors of St Mark's.

**September 9**<sup>th</sup> – **16**<sup>th</sup> – there are 5 people signed up to go to Wilmington, NC to help WARM in our mission trip. Members going on this year's trip include: Kathy Follett, Rosy Gonzalez, Vickie Ristenbatt, Al and Peg Scholl. We will leave bright and early Saturday September 9<sup>th</sup> to arrive in Wrightsville Beach later that evening. On Sunday, we will worship with our friends and hosts at Little Chapel on the Boardwalk Presbyterian Church in their morning beach service and then later in their traditional service in their sanctuary. Our work week is Monday September 11<sup>th</sup> through Thursday September 14<sup>th</sup>. We begin our trip back home Friday with a stop in Woodstock, VA to visit our friends of many mission trips. How can you help? Prayers for good weather and safety on our travels and at the job sites.

### Report of the Consistory - August 2023

The next community dinner will be held on Saturday, November 11, 2023, and will be similar to the drive through event held earlier in the year. The annual blessing of the backpacks will be held on Sunday, August 27, 2023, during the worship service. The Christians in Action committee has identified 25 individuals who are on the visitation list. The 25 members are either homebound (nine), living in retirement facilities (fourteen) and one lives at Kindred Place. The music committee requested that meditative music be reduced to two sections being played prior to the service - approximately five minutes before the service begins. A bid was approved for Yarnell Security to install sensors on the doors in the tower and at the Mifflin Street entrance. A new informational brochure has been prepared to give to visitors. The information board for the sign at 8th and Monument Streets has been received and will be installed.

### Financing a Canal

When the Schuylkill and Susquehanna Navigation Co. was charted in 1791, enthusiasm abounded and demand for subscriptions in the new company soon overcame the availability of such stock. A lottery determined who the lucky shareholders would be. The initial \$400,000 was designated to make the Tulpehocken, the Quittapahilla, and the Swatara navigable from Reading to Middletown through dredging, with a hand-dug canal connecting the origins of the "Tully" and the Quitty". As the project evolved, these original plans were altered in favor of a canal beside the Tulpehocken and a route which avoided the Quittapahilla for a course which reached the Swatara more directly.

Today the term "cost over-runs" is a norm in the construction industry, and it quickly caught the S. & S. Navigation Co. and force it into bankruptcy. After several miles of canal were dug (perhaps five to ten), the construction of five locks on the Ley farm (now Tulpehocken Manor), and the difficult excavation of rock through hard limestone known as "The Narrows" (Calcite Quarry), the young company found itself without funds by 1795.

Not only had the work been expensive, but many of the stock holders were no longer willing or able to pay the installments on their subscriptions. Robert Morris, for example, the president of the company, began speculating in real estate in Washington, D.C., the nation's new capital, and eventually wound up in debtor's prison in Philadelphia. By 1795 all progress on the canal had halted and bankruptcy was declared in 1797.

To "jump start" the enterprise, the canal company requested and was granted permission to operate a lottery to raise another \$400,000 in funds for this and a sister company, the Delaware and Schuylkill Navigation Co. forging a canal from the Delaware River at Philadelphia up the Schuylkill to connect with the S. & S. Canal. The lottery proceeds were to be divided, 2/3 to the S. & S. Navigation Co. and 1/3 to the D. & S Canal.

The governor of the state witnessed the drawing for prizes beginning on March 7, 1797. Later he appointed a commission of three who assumed this responsibility.

By 1811 the lottery had only generated some \$60,000 for the treasury of the company which was far short of what was needed to resume construction. The state's reaction was to merge the two canal companies into one unit, the Union Canal Co. This union was also brought about by Philadelphia bankers and wealthy citizens who were willing to invest in the new company if they could have a hand in the affairs of the company.


A new act of the State Legislature granted the Union Canal Co. the exclusive right to sell lottery tickets in the State of Pennsylvania in order to raise the \$340,000 balance which had previously been authorized. This time lottery agents marketed their tickets on a national scale exhibiting a competitive zeal that would rival present-day advertising campaigns. In some two decades and some 50 drawings, \$33 million in prize money was awarded. Incredibly only \$270,000 in proceeds were ever realized by the company. Although a 15% return was expected on the sale of tickets, the figure reached closer to 5%.

Instead of finishing a waterway, the Union Canal Co. became little more than a lottery company. Organizations such as churches and schools wishing to hold lotteries could do so with the permission of the canal company and a percentage of organization's income. The funds generated provided well for the more than adequate salaries of the officers of the company but left nothing for the canal itself.

In March 1819 the State Legislature reacted by placing restrictions on the new company. Construction on the canal had to begin within three years or their charter would be revoked. If work stopped for a period of 3 months, the officers could not receive their salaries. The route of the canal was limited from Reading to Middletown, and the company was directed to sell more stock. This latter directive was a difficult one to implement until the Legislative Act of 1821 set forth a guarantee of 6 % interest by the State on new investments in the canal company for a period of 25 years. This move stimulated investors, new stock was sold, and the canal was finally completed.


While the financial woes of the Union Canal were solved for the present, and the future appeared positive, financial difficulties would appear and reappear until the canal's final demise in 1885. But in the 1820's, the "Golden Link" to the West, the Union Canal, was about to shine!

### NO BAKE GRANOLA BARS

Great quick and easy granola bar recipe that kids can make.

### Ingredients:

2 cups rolled oats 1 ¼ cups chunky peanut butter 1 cup ground flaxseed

34 cup honey

34 cup dried cranberries

½ cup chocolate chips

1/4 cup sliced almonds

### Directions:

- 1. Stir oats, peanut butter, flaxseed, honey, cranberries, chocolate chips and almonds together in a bowl; press into a 9x11-inch baking dish, using the back of a spatula to press into a flat layer.
- 2. Refrigerate mixture at least 1 hours.
- 3. Cut into 12 bars and wrap each individually in plastic wrap for storage.




